To this end, interested parties wishing to carry out research in the Unit may formalise their interest by submitting personal, academic and professional details, provided they meet all of the following conditions:

- Academic qualifications in Ecology or a related field;
- Relevant scientific and/or professional activity in the field of Biodiversity;
- Relevant curriculum vitae in the scientific area(s) indicated;
- Preference will be given to those with a PhD and relevant international professional experience.

Those interested should submit:

- Letter addressed to the Rector of the University of Aveiro, indicating that they are applying for research in the area of Biology, in the field of Ecology and Biodiversity, at the Centre for Environmental and Marine Studies (CESAM) of the University of Aveiro (Form available at: <https://www.ua.pt/file/76532>);
- Detailed curriculum vitae, which must include all indicators of scientific and technological production and co-operation with society;
- Documentation proving possession of an academic degree and professional qualifications.

Expressions of interest should be sent **by 11 December 2023** to the Coordinator of CESAM - Centre for Environmental and Marine Studies, University of Aveiro, by email to [cesam-concursos@ua.pt](mailto:cesam-concursos@ua.pt).

This notice aims to constitute a pool of interested parties whose expressions of interest will be assessed by the competent bodies of the University of Aveiro when and if justified by the needs of the service and the merit of the curricula submitted, in any case complying with the procedure laid down in article 4 of Regulation no. 609/2015, published in Diário da República no. 174, of 7 September, and in articles 6 and 36 of the ECIC, applicable ex vi of the first regulation, for the recruitment of visiting researchers. This publicity **does not, therefore, constitute the opening of any call for tenders**, and consequently there is no right to be hired as a result of the relative comparison of the curricula submitted.

Under the terms of the law, the University of Aveiro guarantees the confidentiality of the personal documentation received, which it undertakes to return upon express request.
